**[ STATEMENT OF PROBABLE CAUSE / NARRATIVE ]**

On 4/19/2016, I was dispatched to 7820 Parkwood Dr in reference to a landlord tenant dispute.

Upon my arrival, I spoke to April Melvin, who advised the following. On 4/13/2016, April's landlord, Dorothy Rogers, approached April and advised her that she needed to vacate the trailer by 4/15/2016. April acknowledged that the eviction was not legal but was not contesting it and agreed to leave. April injured her foot which limited her ability to move so she was a couple days past the deadline. April stayed in the trailer last night and had to go to a doctor's appointment at 0800 hours and returned to the residence at approximately 1500 hours after getting a text from her boyfriend's aunt telling her that Dorothy was in April's trailer removing items. When April returned home, she noticed that the clothes she had packed in a blue tote were dumped on the ground and the tote was missing. April's refrigerator was open and the eighty dollars worth of food that was in the refrigerator when April left was also missing. April also noted that a blanket used as a black out curtain was no longer hanging over the window and could not be located. April spoke to Dorothy on the phone who told her she could come get her food but when April went to retrieve the food, Dorothy denied have the food. April completed a sworn written statement which will be submitted into Records.

I also spoke to April's live-in boyfriend, Jay W. Owens who stated the following. Jay and April came home because he received a text from his aunt stating that Dorothy was taking things out of their trailer. Upon their arrival back at the trailer, Jay saw that the clothes that were in April's tote are now on the floor and food was gone.

April listed the value of missing items as follows:

I responded to 7813 Fleetwood Dr and spoke to Dorothy Rogers, who stated the following. April called on 4/1/2016 and advised that she did not have the rent this month and would be vacating the residence once she found a new place to stay. April told Dorothy that she was going to leave her household goods in the trailer. Dorothy did not have any written documentation for any of this. Earlier today a representative from Gulf Power came to the trailer park and had to shut off several trailers' power, 7820 Parkwood Dr being one of them. Dorothy went into the trailer with one of her workers, Jessica, and wanted to clean out the refrigerator before the food spoiled and caused damage. Jessica made entry thru the back door of the trailer which was unlocked. Dorothy could not find a box, so she emptied one of the totes she found inside the trailer and put the groceries from the fridge into the tote. Dorothy advised what food was not given away, she had thrown out. Dorothy had her worker put the tote inside the fence along her residence.

I found the bluish green plastic tote outside along Dorothy's trailer. I took possession of the tote and returned it to April.

On 4/22/2016, I made contact with Jessica Sosa, at her address located at 7846 Marlette Dr

Jessica stated the following. On 4/19/2016, At Dorothy Roger's request, Jessica entered the trailer located at 7820 Parkwood Dr. because the girl who lived there was supposed to be moving out. The back door was open and Jessica went inside. Inside the trailer was messy. Jessica opened the front door for Dorothy and went to sit in her truck. Jessica saw Dorothy take the items out of the refrigerator.

I also spoke to Jessica's Boyfriend, Howard Curtis Johnson, who stated the following. Howard was with Jessica and Dorothy on 4/19/2016, when he was asked to go into the trailer and clear out April's belongings. Howard and Jessica went into the residence through the back door and opened the front door. Howard saw Dorothy take a white quilt out of the trailer, along with the food from the refrigerator.

Based on the sworn statements from those involved, Dorothy Rogers admission to having the food removed and disposed, and locating the tote belonging to April in Dorothy's possession, I will be requesting a warrant for the arrest of Dorothy Rogers for violation of F.S.S. 812.014.2e Petit Theft 1st degree \$100 under \$300.

This incident occurred in Santa Rosa County, FL.

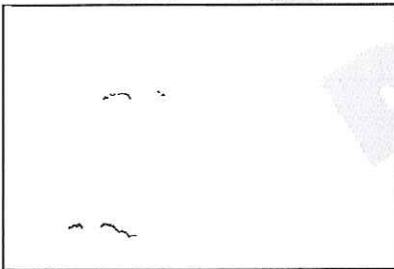

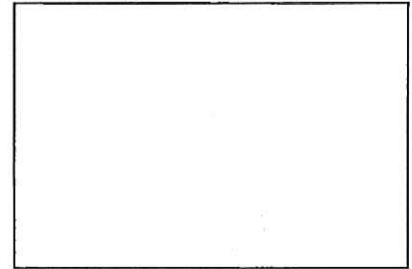
